1. Aims

This policy aims to:

- Set out our approach to requiring a uniform that is of reasonable cost and offers the best value for money for parents and carers
- Explain how we will avoid discrimination in line with our legal duties under the Equality Act 2010
- Clarify our expectations for school uniform

2. Our school's legal duties under the Equality Act 2010

[The Equality Act 2010](#) prohibits discrimination against an individual based on the protected characteristics, which include age, sex, disability, race, religion or belief, pregnancy and maternity, and gender reassignment.

To avoid discrimination, our school will:

- Avoid listing uniform items based on sex, to give all pupils the opportunity to wear the uniform they feel most comfortable in or that most reflects their self-identified gender
- Make sure that our uniform costs the same for all pupils
- Allow all pupils to have long hair (please see additional note in 4.1)
- Allow all pupils to style their hair in a way that is appropriate for school and makes them feel most comfortable (see additional note in 4.1, appendix b and appendix c for further information)
- Allow pupils to wear headscarves and/or other religious garments
- Allow pupils with sensory or physical needs to make reasonable adaptations to their uniform depending on their specific needs
- Allow for reasonable adaptations to our policy on the grounds of equality by asking pupils or their parents to get in touch with the Headteacher who can be contacted through the School Office, who can answer questions about the policy and respond to any requests. These will be considered on a case-by-case basis.



3. Limiting the cost of school uniform

Our school has a duty to make sure that the uniform we require is affordable, in line with statutory [guidance](#) from the Department for Education on the cost of school uniform.

We understand that items with distinctive characteristics (such as branded items, or items that have to have a school logo or a unique fabric/colour/design) cannot be purchased from a wide range of retailers and that requiring many such items limits parents' ability to 'shop around' for a low price.

We will make sure our uniform:

- Is available at a reasonable cost
- Provides the best value for money for parents/carers
- We will do this by:
 - Carefully considering whether any items with distinctive characteristics are necessary
 - Limiting any items with distinctive characteristics where possible by making these items optional.
 - Limiting items with distinctive characteristics to low-cost and/or long-lasting items, such as book bags and PE bags.
 - Avoiding specific requirements for items pupils could wear on non-school days, such as coats, bags and shoes
 - Keeping the number of optional branded items to a minimum, so that the school's uniform can act as a social leveler
 - Avoiding different uniform requirements for different year/class/house groups
 - Avoiding different uniform requirements for extra-curricular activities
 - Considering alternative methods for signalling differences in groups for interschool competitions, such as creating posters or labels
 - Making sure that arrangements are in place for parents to acquire second-hand uniform items
 - Avoiding frequent changes to uniform specifications and minimising the financial impact on parents of any changes
 - Consulting with parents and pupils on any proposed significant changes to the uniform policy and carefully considering any complaints about the policy



4. Expectations for school uniform

4.1 Our school's uniform

- All branded items of school uniform are optional.
- The colours specified for uniform items as identified in Appendix A are mandatory.
- For expectations around jewellery, accessories and hairstyles we have taken into account the Equality Act 2010 so to ensure an inclusive approach and to avoid discrimination. Please see additional notes below for detailed guidance.
- Good footwear that is suitable for school activities is important, and the school permits plain black shoes and plain trainers. Please note that children are not permitted to wear shoes with a heel or boots of any type, with the exception of wellington boots.
- Children may choose to wear tailored grey shorts or a pale blue gingham summer dress. At different times throughout the school year, depending on the weather and school activities, children may be required to wear or bring in wellington boots.
- It is mandatory that children wear their uniform appropriately, for example, when wearing skirts or dresses these should be an appropriate length and if wearing shorts then these should not be tight or a hot-pant style. Shorts should take into consideration the length of the t-shirt/jumper and be an appropriate length for the age and height of the child as deemed appropriate by the Senior Leadership Team. Children will be asked to change into a PE Kit if any clothing is deemed inappropriate by the Senior Leadership Team, and this will then be followed up with a phone call to the parent or carer.
- At St John's we celebrate our children's uniqueness and hairstyles are an important part of an individual's identity. However, it is a requirement of the school that all children will tie all of their hair back, if it is in their eyes or at a length that is shoulder or longer. This includes dress up days. This requirement is for health and safety purposes, the importance of good hygiene, and to aid good concentration when learning. If a child hasn't got a suitable hair band, they will be provided with one by the school. This expectation applies at all times when the school uniform policy is applicable.
- Children are not permitted to wear any type of make-up including nail varnish. If children attend school wearing make-up they will be provided with the means to remove it. If your child is unable to independently remove their make-up, they will be assisted by an appropriate member of staff.
- Jewellery may be worn during school times as long as the following criteria applies: jewellery worn is of religious significance and has to be worn; earrings worn are studs and not dangly or hoops. In general, wrist bands, bracelets, bangles, and necklaces are not to be worn.
- Children may wear suitable and inexpensive watches for the purposes of telling the time and monitoring steps, but they mustn't pose a safeguarding concern e.g. being able to record or take photos or send or receive calls or messages. The diameter of the clock face mustn't be bigger than 4cm.

4.2 Where to purchase it

- Our branded items relating to our school uniform can be purchased by visiting Smarty Schoolwear in Hatfield or by visiting their website: <https://www.smartyschoolwear.co.uk/>. If you prefer to buy non-branded school items, then these can be found in most supermarket stores and clothing retailers.
- Throughout the year our Parent Teacher Association will provide the facility to purchase second-hand uniform items.



5. Expectations for our school community

5.1 Pupils

Pupils are expected to wear the correct uniform at all times (other than specified non-school uniform days) and follow the guidance within this policy at all times while:

- On the school premises
- Travelling to and from school
- At out-of-school events or on trips that are organised by the school, or where they are representing the school (if required)

Pupils are also expected to contact the Headteacher by speaking with a member of staff in the School Office if they want to request an amendment to the uniform policy in relation to their protected characteristics.

5.2 Parents and carers

Parents and carers are expected to make sure their child has the correct uniform and PE kit, and that every item is:

- Clean
- Clearly labelled with the child's name
- In good condition

Parents are also expected to contact the Headteacher by speaking with a member of staff in the School Office if they want to request an amendment to the uniform policy in relation to:

- Their child's protected characteristics
- The cost of the uniform

Parents are expected to lodge any complaints or objections relating to the school uniform in a timely and reasonable manner.

Disputes about the cost of the school uniform will be:

- Resolved locally
- Dealt with in accordance with our school's complaints policy
- The school will work closely with parents to arrive at a mutually acceptable outcome.

5.3 Staff

Staff will closely monitor pupils to make sure they are in the correct uniform. They will give any pupils and families breaching the uniform policy the opportunity to comply but will follow up with the headteacher if the situation doesn't improve.

Ongoing breaches of our uniform policy will be dealt with by the Headteacher.

In cases where it is suspected that financial hardship has resulted in a pupil not complying with this uniform policy, staff will take a mindful and considerate approach to resolving the situation.



5.4 Governors

- The governing board will review this policy and make sure that it:
- Is appropriate for our school's context
- Is implemented fairly across the school
- Takes into account the views of parents and pupils
- Offers a uniform that is appropriate, practical and safe for all pupils

The board will also make sure that the school's uniform supplier arrangements give the highest priority to cost and value for money, for example by avoiding single supplier contracts and by re-tendering contracts at least every 5 years.

6. Monitoring arrangements

This policy will be reviewed every two-years by the Headteacher. At every review, it will be approved by the full governing board. The monitoring of uniform expectations being followed takes place daily and a persistent breach, if not for financial reasons, will be followed up by using the behaviour policy.

Appendix 1: Pupil's Dress Code

Uniform List

- Grey trousers
- Grey school shorts (summer term only)
- Grey skirt
- Grey pinafore dress
- Grey/White tights/socks
- Pale blue gingham dress in summer – there are many different styles – all are welcome as long as the gingham part is pale blue and is an appropriate length.
- White polo shirt (logo optional)
- Navy sweatshirt (logo optional but preferable)
- Navy fleece (not required but optional with or without logo)
- Navy cardigan (logo optional but preferable)
- Plain black shoes or plain black trainers (no boots of any type unless wellington boots are required)
- Optional – children may wear cycling type black shorts underneath dresses and skirts.

PE Kit (n/a in Nursery)

- Plain Black shorts or skorts can be worn
- Optional – children may wear
- Plain white t-shirt (round neck)
- Plain black joggers (weather dependent)
- School jumper or fleece maybe worn when cold
- Trainers

All jewellery must be removed and at the very least studs must be covered up with masking tape during PE lessons. If children are wearing jewellery, they must be able to remove jewellery and put it back in independently.



Appendix 2: Pupil's Dress Code - Additional Items

Required Items

- Coat (suitable for the weather)
- Book-bag/backpack
- PE bag
- Water bottle

Optional Items

- Watches (smart watches will be removed and confiscated if they have the ability to take recordings of any type or the capacity to take photos or receive calls and messages).
- In Year 5 and Year 6, children may bring in a mobile phone if they are travelling to/from school without an adult – phones must be handed in to their teacher at the start of registration.
- Plain navy cap / sun hat or pale blue gingham summer hat – weather dependent.
- Hair bands/ties must be either plain navy or blend in with the child's natural hair colour – these should also be discreet.



Appendix 3: The Halo Code

Our school champions the right of staff and students to embrace all Afro-hairstyles. We acknowledge that Afro-textured hair is an important part of our Black staff and students' racial, ethnic, cultural, and religious identities, and requires specific styling for hair health and maintenance.
